1. The vendor should be a registered firm with Odisha Value Added Tax Authority and should furnish copy of the registration certificate

along with the quotation.

2. The quotation not submitted in prescribed format or in prescribed manner, shall be rejected.

3. Warranty:-

The vendor shall stand for warranty against defective materials / manufacturing defects and workmanship for the work carried out by

him for a period of 02 years and extended warranty of 01 year to be considered in the quotation format from its commissioning

/handing over & make good /repair/replace the faults during this period without any extra cost, failing which the same shall be got done at the risk and cost of the vendor. Further, (i) Annual Maintenance Contract (AMC) for 4 th. & 5 th. Year has to be offered separately in percentage wise and indicate the percentage amount. (ii) Annual Maintenance Contract (AMC) for 6 th. & 7 th. Year has to be offered separately in percentage wise and indicate the percentage amount as per enclosed Annexure - 1.

- 4. The vendor not having VAT Registration certificate shall not be eligible for submitting the quotations. The blacklisted vendors shall also not be eligible for participating.
- 5.The Sales Tax / VAT clearance certificate for the preceding financial year and copy of Income tax return copy, PAN card, TIN No, upto date VAT clearance certificate, proof of experience of executing the similar work shall be submitted.
- 6. All or any of the quotation submitted can be rejected without assigning any reason thereof.
- 7. Advance payment /part payment will not be entertained before completion and handing over the work.
- 8. No claim can be made due to some unforeseen delay for release of payment.

- (ii) 3 % of the security money will be released after completion of 5 th. Year AMC period.
- (iii) Balance 4 % of the security money will be released after completion of 7 th. Year AMC period.
- (iv) Annual Maintenance Contract (AMC) charges for 4 th. & 5 th. Year and 6 th. & 7 th. year will be paid after successful completion of respective AMC period at the end of 5 th. and 7 th. Year.
- 10. All the transit risk shall be responsibility of the vendor.
