4. The Bid documents will be available in the website: [www.tendersOdisha.gov.in](http://www.tendersOdisha.gov.in) from **26.10.2012 to 09.11.2012 upto 5.00 P.M. for online bidding.**
5. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
6. Bids shall be received **only "on line" on or before 09.11.2012 upto 5.00PM.**
7. Bids received on line shall be opened at **11.00 Hours on 14.11.2012 (S.L. No. 1 to 10) and 15.11.2012 (S.L. No. 11 to 20)** in the office of the Chief Engineer, **The Odisha State police Housing & Welfare Corporation Ltd., Bhubaneswar** in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on

the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

8. After the date & time of receipt of bid is over, the original Bid security and Demand draft towards cost of Bid documents shall be submitted in the office of the undersigned before opening of Bid as specified at Column.04 & 05 above, during office hours on working days failing which the bid will be rejected.
9. The cost of bid documents in demand draft issued from any Nationalised Scheduled Bank may be prepared in favour of "**The Odisha State police Housing & Welfare Corporation Ltd.**" **Payable at Bhubaneswar.**
10. Other details can be seen in the bidding documents.
