I am directed to say that during review of the progress of works executed by the OSPH & WC Ltd, it is revealed that projects worth Rs.923.86 crore executed by the Corporation, are on various stages as given below.

Consequent on huge pendency of works with the OSPH&WC Ltd., the Works department was moved to take up the works awarded to OSPH & WC Ltd. which have not yet started. In this respect, the response of the Works Department is awaited.

During review it was emerged that the funds have already been placed with the OSPH&WC Ltd. for execution of the works under various schemes/sources. On drawl and placement of funds with the Corporation, the expenditure has been booked against the user agency. Midway transfer of funds from OSPHWC to PWD may lead to problems in maintenance and dislocation of accounts.

On the other hand, funds lying Idle with the Corporation serves no purpose and the State must have to create the capital asset with the available funds within a specified time frame. In the circumstance, the user organizations may appreciate the gravity of the situation and take all necessary steps for completion of the old projects in a time bound manner for meaningful utilization of funds placed with the OSPH&WC. In case of new projects, the services of other executing agency like R & B of the State may be explored for speedy implementation & utilization of funds out of the budget estimates.
