Restriction on the use of plastic/polythene materials in the

Secretariat and sub-ordinate offices

Sir.

With reference to the above subject, I am to inform you that the State Government have issued a Notification No. ENV-I-57/2018-F&E/21103 dated 29th September, 2018 imposing restrictions on indiscriminate use, manufacture, sell, import and storage of Polythene carry bags within the limits of 6 Municipal Corporations/Municipalities (Bhubaneswar, Cuttack, Berhampur, Sambalpur, Rourkela and Puri) by which the use of such dangerous material could be minimized, since they are non-biodegradable and are a serious threat to the ecology. A copy of the above Order issued under section 5 of the Environment (Protection) Act, 1986 is enclosed.

In this connection, it would be better if an example is set in all Departments of the Secretariat as well as the sub-ordinate offices by not using materials made up of plastic material such as plastic glass, plates, spoons and water bottles of less than 200 ml capacity and even plastic folders etc. which are not confirming to the Government order.

It is therefore requested to kindly issue necessary instructions to Departments and sub-ordinate offices under your jurisdiction so that use of plastics/polythene darry bags, which are not permissible under the Notification, can be restricted.
