Sub: - 'Human Rights Pledge' to be taken on Human Rights Day on 10th December every year.

Sir,

In inviting a reference to the subject cited above, I am directed to say that the Secretary General, NHRC, New Delhi has intimated that the National Human Rights Commission celebrates the 'Human Rights Day' on 10th December every year by holding a special function in New Delhi and the Commission has adopted a Human Rights Pledge to be taken on Human Rights Day on 10th December every year. The National Human Rights Commission is of the view that administering the oath by the State Human Rights Commissions alone will have a limited impact. Human Rights Pledge is to be given its due significance particularly in the context of the observance of human rights by all concerned agencies which impact upon the daily life of citizens. He has communicated the following suggestions of NHRC to consider for necessary action.

- (a) To administer Human Rights Pledge to all the personnel of law enforcing agencies including State Police, Prison Staff, etc. This Pledge may be administered to all their rank and file at the stage of passing out from their training institutions as well as on 10th December (Human Rights Day) each year in their respective offices.
- (b) To consider introducing Human Rights Pledge to all Government Servants and Offices on the pattern of other such pledges like Sadbhavana Pledge (20th August), Martyr Day Pledge (30th January) and Anti-Terrorism Day (21st May).
- (c) State Education Boards to incorporate the Human Rights Pledge in a prominent section (front and back cover) of the text books of class 10 and 12.
- (d) To incorporate in the Annual Confidential Report/Annual Performance Appraisal Report (ACR/APAR) of all Group A & B Government employees regarding

description, approach and action taken on issues of Human Rights violations, if any, noticed / brought to the notice / handled by the Officer in the course of his duties.

A copy of the letter dated 20.12.2017 of the Secretary General, NHRC, New Delhi with the above suggestions is sent herewith for necessary action.

The International Human Rights Day is observed all over the world every year on 10th December to commemorate the adoption of the Universal Declaration of Human Rights by the United Nations General Assembly by organizing special functions.

- The National Human Rights Commission celebrates the Human Rights Day, on 10th December every year, by holding a special function in New Delhi,
- The Commission has adopted a Human Rights Pledge to be taken on Human Rights Day on 10th December every year (Copy enclosed).
- The National Human Rights Commission is of the view that administering the oath by the State Human Rights Commissions alone will have a limited impact. Human Rights Pledge is to be given its due significance particularly in the context of the observance of human rights by all concerned agencies which impact upon the daily life of citizens and. accordingly, gives following suggestions for your consideration:
 - (a) Human Rights Pledge may be administered to all the personnel of law enforcing agencies including State Police, Prison Staff, etc., which frequently come in conflict with the citizens on human rights issues during their normal course of operations/activities. This Pledge may be administered to all their rank and file at the stage of passing out from their training institutions, as well as on 10th December (Human Rights Day) each year in their respective offices.
 - Taking into account the importance of human rights in the life of a citizen, it is imperative to introduce the Human Rights Pledge not only to law enforcing agencies as envisaged in (a) above, but also to consider introducing it to all Government Servants and officers on the pattern of other such pledges like Sadbhavana Pledge (20th August), Martyr Day Pledge (30th January) and Anti-terrorism Day (21st May).
 - Human Rights as an issue needs to be appropriately put in the school and college curriculum so as to bring into focus its objectives and significance in the formative young years of the citizen. For this purpose, State Education Boards may also be directed to incorporate the Human Rights Pledge in a prominent section (front and back cover) of the text books of class 10 and 12.
- (d) A column may also be incorporated in the Annual Confidential Report/ Annual Performance Appraisal Report(ACR/APAR) of all Group A & B state Government employees regarding description, approach and action taken on issues of Human Rights violations, if any, noticed/brought to the notice/handled by the officer in the course of his duties. This will go a long way in proper central positioning of Human Rights in the work sphere of officers. There is already a column in ACR/APAR forms dealing with SC/ST etc. and Human Rights actually are concerned with all the marginalized/disadvantaged sections of population (not just SC/ST) like women, children, bonded labour, LGBTI, minorities, undertrials and prisoners, etc.
- Taking into account the importance of Human Rights in the daily life of a citizen and the stress on "minimum government-maximum governance". I request you to kindly consider the above four suggestions, in Para 4 above, and issue necessary government orders at the highest level. We are addressing all State Governments in this regard and shall be grateful if you kindly send us a copy of the government orders issued by your State early to enable us to share

- 2. - Pledge taker (individual or organization) can take pledge online by a) entering her/his details such as name, gender, aadhar no., date of birth, pin code, state, district, email, mobile no. etc., in the Entry
- In the next step, after selection of language, pledge is read by the (b) pledge taker.
- (c) Pledge takers click on the 'Pledge' button to take pledge and enter a One Time Password (OTP) received on their mobile.
- After the above three steps, a certificate of pledge is generated. (d) This certificate can be printed, downloaded and is also sent to email ID of the pledge-taker.
- NHRC is taking up the issue of Online Pledge by all Government and non-Government Officers throughout the country over the next several
