The tender should accompany earnest money deposit of Rs.5000/- (Rupees Five Thousand) only in shape of Bank Draft / Pay order in favour of Odisha State Police Housing & Welfare Corporation Ltd., Bhubaneswar, which will be refunded to the tenderers whose tenders are not accepted except in case of the successful bidder.
