4. OTHER ELIGIBILITY CONDITION-

- a. The candidate must be a citizen of India.
- **b.** The candidate must be in good physical and mental condition, bodily health and free from any physical disorder. A candidate, who after such medical examination is not found to satisfy these requirements shall not be appointed to the post.
- c. The candidate must be able to speak / read & write Odia fluently and must have passed at least one examination in Odia language equivalent to that of Medium English School Standard conducted by the Board of Secondary Education, Odisha, or the Education Department of Government of Odisha or any other Board or Council of Secondary Education approved by the Government of Odisha in support of passing of Odia language.
- **d.** A candidate, who has more than one spouse leaving, will not be eligible for appointment unless the State Government has exempted his/her case from operation of this limitation for any good and sufficient reasons.
- **e.** Only those candidates, who fulfill the requisite qualification and within the prescribed age limit etc. will be considered eligible.

The applicant must attach self-attested copy of all the mark sheets, certificates/ testimonials/ documents from HSC/10th onwards towards proof of qualification, age, mark secured, caste/SEBC, experience etc. along with application form. In case a Degree is based on semester pattern, then the candidate needs to submit the mark sheets of all semesters including the final mark sheet of final semester.
